DEFERRED REPAYMENT LOAN



We know that financing your studies can often be a difficult and frustrating task. You may need money for textbooks, an organiser, to finance a new computer, or simply to see you through your course.

Whatever the reason, National Australia Bank can help relieve the pressure by offering the National TSP Deferred Repayment Loan to eligible students of Australian Careers Business College.

The National TSP Deferred Repayment loan allows you to borrow money now, when you need it most, and pay it back after completing your course, when your earning capacity is greater (the maximum deferral period is 5 years). You can also save interest by making repayments before completing the course.

So if you want to get a head start on your career by enrolling in a Australian Careers Business College Diploma or Certificate course and need to look at options of how to finance your study, a National TSP Deferred Repayment Loan may well give you the financial assistance that you need.

To Be Eligible To Apply For A National Tsp Deferred Repayment Loan:

- You must be over 18 years of age;
- You must be an Australian Citizen or Permanent Resident;
- You will need someone to nominate as a Guarantor e.g. Parent/Guardian or similar responsible person;
- You must have a current Letter of Offer from Australian Careers Business College.

How To Apply:

- Pay your \$200 course enrolment deposit which will secure your enrolment at Australian Careers Business College and receive your Letter of Offer;
- Visit any National Australia Bank branch nominated for your Australian Careers Business College Campus with the following information:
 - 1) Personal identification details. e.g. birth certificate/ passport, drivers license, photo ID Card
 - 2) Evidence of any income. e.g. Two recent payslips (from Part-time job), AUSTUDY payments etc.
 - 3) Details of what you owe (liabilities). e.g. Any other loan statements, credit card statements, etc
- The National Australia Bank Loans Officer will then guide you through the remainder of your application process.

IMPORTANT: Please remember to leave sufficient loan processing time between the lodgment of your application and the intended start date of your course.
